



ECHS Student Parking

Parking on campus is a privilege. Students may not park on campus without a parking permit from HGTC or a temporary permit from ECHS. The HGTC Parking permit must be displayed facing the windshield.

Students who fail to follow all ECHS Driving Expectations as well as HGTC parking guidelines are subject to monetary fines and/or loss of parking privileges.

A completed application with parent signature, as well as a copy of students' license, car registration, & proof of insurance will be needed for ECHS records.

ECHS Driving Expectations

1. All school rules apply in vehicles and parking lots. Failure to abide by the rules will result in loss of driving privileges and disciplinary action.
2. Students **must also** register their cars with HGTC Public Safety in Building 1100.
3. Students must be registered in 10th, 11th, or 12th grade to have parking privileges.
4. No parking permit will be issued by the college until all outstanding fees are paid.
5. Students should park in designated student parking spaces only (*Parking spaces marked Teachers/ Staff are for Teachers/ Staff only*).
6. Students who drive to school should lock and leave their cars promptly once they arrive on campus. No loitering is allowed in the parking lot. Students will not be allowed to return to their cars without permission from administration.
7. The student agrees he/she will not bring onto campus or keep in his/her vehicle while it is on school grounds any gun, ammunition, explosive, knife, blackjack, other weapon, alcohol, illegal substances or paraphernalia.
8. Students are to obey all traffic signals, signs, and markings on campus (*the campus wide speed limit is 10 MPH*).
9. At the end of the school day, students are to exit the parking lot by 2:30, unless they have after school detention, tutoring, club meetings or are with a teacher. Students are not to move their vehicles from one space to another after school.
10. Students cannot allow other students to use their parking permit.
11. All vehicles on campus are subject to search. The school fully cooperates with the local and state law enforcement officials and the R.A.I.D. organization in regard to vehicles on the HGTC campus.
12. The school, district, and college will not be liable for damages or theft to vehicles.
13. To receive an HGTC Parking Permit from the office of Public Safety, students must present a driver's license, proof of registration, and a current HGTC schedule. Students can receive a temporary parking permit from ECHS that is good for up to 1-3 days, but students must register their vehicles with the college.

Parking Violations - Students who receive a parking ticket must clear the fine through HGTC. Failure to clear the fine will cause a hold on the students' HGTC account, which will result in a hold on college transcripts, graduation, and registration for classes, etc..
