- Parents are encouraged to participate on a committees that meets 3 times a year and as members of parent organizations, such as our PBE Parent Organization at both the school and district levels and to serve as volunteers for classroom, school, and district -wide activities
- Professional development opportunities for teachers, administrators, and other district employees shall be offered to enhance the ability of schools to effectively service all students, parents, and families (see Title I Newsletters)



At the beginning of the year parents must be informed of their right to request information about qualifications of teachers and paraprofessionals. (District). If substitutes who are not properly certified are used for four or more weeks, a letter must be sent to parents explaining the current classroom status. (School)


